#### **Submission Requirements**

- Completed entry form.
- A resumé of the person being nominated and this should include the following:
  - Background of the nominee's involvement with the Hospital Caterers Association.
  - Brief history of their career within the NHS.
- Evidence of the achievement/supporting documentation during the period January 2019 to December 2019 that have been instrumental in having a positive impact in particular to Patient experience and showing the focus and delivery of the 'Last 9 Yards', initiatives of Nutrition and Hydration 24/7/365, evidence of training of teams or apprenticeship programs in place for catering employees or teams.
- A reference from either a current Branch Officer/ employing authority.

### **Chairman's Choice Award**

The Branches of the HCA are the cornerstones of the Association, providing an active professional support network around the UK and Northern Ireland for healthcare catering professionals who face the same challenges the industry brings and are striving for similar targets. #### **Submission Requirements**

- Completed entry form.

  - How the branch supports training and development of members, including inter-Branch activities.
  - What the branch is doing to encourage future managers and supervisors to engage with the HCA.
  - The timely submission of Financial Accounts.
  - How the branch showcases their developments and achievements on website and in the journal.

# Catering Service Team of the Year Award

This award aims to give recognition to a Catering Team which has made an outstanding contribution to NHS catering in their regional area.

#### **Submission Requirements**

- Completed entry form.
- Written nominations (500 1,000 words) should demonstrate the team's:
  - High level of management skill, initiative, and commitment in devising and implementing catering service objectives or strategy, which has brought about a positive change or improvement in their food service across their organisation.
  - Energetic and imaginative approach to its work as well as illustrating active involvement of staff in the successful development and implementation of the catering service objectives or strategy.
  - Whilst looking at originality and creativity, other factors contributing to achieving a successful outcome will be taken into account. These will include areas such as staff engagement, an affinity with the customer profile and overcoming current financial challenges together with a proven track record in meeting catering service objectives/strategy.
  - Exemplary people management and teamwork across all staffing levels will have ensured that not only were service objectives met and strategies successfully implemented but the results will show how the catering service has moved forward year on year.

#### **Trade Stand award**

Our events would not be achievable without the support of the trade. This Award is presented to the Trade Stand that, in the eyes of the judging panel of the President and Vice-President, stood out for them at the National Leadership & Development Forum.

### **Efficiency & Improvement Award**

Sponsored by Hefma



This award is for Members/NHS Trusts/Board/HCA Branches to put forward nominations to demonstrate how they introduced a new idea, development which helped to improve catering service to patients or retail, which delivered service improvement and improved efficiency and productivity.

#### **Submission Requirements**

- Completed entry form.
- Written nominations (500 1,000 words) should demonstrate:
- a resumé of the individual or team and should demonstrate, evidence-based, on how the innovation had some combination of the following attributes:
- Originality:
  - Whether it's a new idea or a variation of an existing idea.
  - If developed independently or in co-operation with others.
- Productivity/Efficiency:
  - How it improved individual or team productivity.
  - How it improved efficiency and is demonstrated in National financial benchmarking.
- Impact:
  - The fundamental changes made.
  - How it impacted on the provision of Support Services.
- Practicality:
  - Whether it was cost effective to implement.
  - ■The risks associated with implementation.
- Measurability:
  - Did it create measureable efficiencies/cost savings.
  - Alternatively did the result provide cost benefit to the NHS.
- Applicability:
  - Is this innovation specific to Support Services?
  - Is the innovation able to applied together organisations outside of the NHS?

#### **Special Contribution Award**

This award will be presented to a person/organisation which has performed a role that has had a significant influence on the provision of services in one or more areas of healthcare catering sector.

Detailed nominations are not sought for this category, as the judging panel will discuss. However if you wish to alert the judging panel to a candidate, submit an entry accompanied by a citation of no more than 500 words.

#### **NEW** - National - Rising Star Award

This new award is for a Full Member who, in the course of his or her work has shown impressive dedication and commitment to furthering themselves and supporting the work of hospital catering, who demonstrates Association values and shows outstanding dedication and commitment.

#### **Submission Requirements**

- Completed entry form.
- a resumé of the person and this should include details on how the nominated individual:
  - Supports and demonstrate Association values.
  - Shows dedication and commitment to developing themselves and others.
  - Demonstrates person-centred care.
  - Shows excellent judgement, drive and initiative.

#### **NEW National - Leadership Excellence Award**

This award is for a Full Member who demonstrates exceptional leadership skills and who excels at mentoring and teaching and shares their knowledge and expertise with students, junior members of staff and/or colleagues, encouraging and motivating them to reach their full potential.

#### **Submission Requirements**

- Completed entry form.
- A resumé of the member and this should include details on how the they:
  - Are an excellent and inspiring teacher.
  - Impart their knowledge and values effectively.
  - Are open and honest, giving staff and/or students beneficial and constructive feedback.
  - Act as a positive role model, encompassing the core values of the Association.
- Please give examples of how the individual excels in their teaching and educational role.

  - Achievements whilst employed in NHS catering.
  - A reference from either a current or past National or Branch Officer.
